The undersigned is directed to refer to this Ministry's O.M. of even No. dated 21.12.2022 (copy enclosed) clarifying that the PIO cards will be accepted as valid travel documents till 31.12.2023 along with valid foreign passport and if in the meantime any deadline is notified by the International Civil Aviation Organization (ICAO) thereby making hand-written PIO card invalid, then PIO card holders may have to obtain appropriate visa from Indian Missions, if they have not converted their PIO cards to OCI cards. It was also clarified therein that Indian Immigration Check Post(s) will continue to consider all PIO cards as valid documents alongwith valid foreign passports till 31st December, 2023.

The matter has been reviewed and it has been decided, with the approval of the competent authority, that the Bureau of Immigration (BoI) will accept PIO cards as valid travel document till 31.12.2024 alongwith valid foreign passport and the Indian Immigration Check Post(s) will continue to consider all PIO cards valid for exit/entry into India till 31.12.2024. This extension of timeline is subject to the condition that if in the meantime any deadline is notified by the ICAO thereby making hand written PIO cards invalid, then PIO cardholders may have to obtain appropriate visa from India Missions/Posts.

In this regard, Indian Mission/Posts abroad may again be requested to advise all the PIO cardholders with valid PIO cards as on 09.01.2015 to apply for conversion of PIO card to OCI card as per the guidelines mentioned in this Ministry's various letters No. 26011/06/2015-OCI dated 16.07.2015, 10.03.2016 and 01·10.2018.
